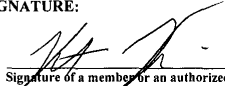

Name and Duration

The name of this Limited Liability Company is TOBY OIL & GAS SERVICES, LLC (hereinafter referred to as the "Company"). The duration of this Company is perpetual. The effective date upon which this Company shall come into existence shall be the date these Articles are filed by the Secretary of State.

ARTICLE II

Principal Office and Mailing Address
