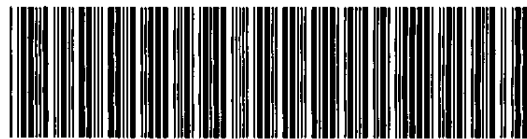



##### Effective Date of Corrections


These Articles of Correction are effective retroactively to the date the Articles of Organization of the Company was filed of record with the Department of State, namely on July 23, 2012.
