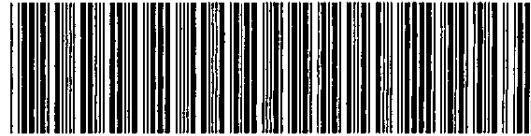



### Amendments




