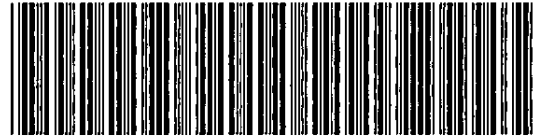



ARTICLE I - Name


ARTICLE VIII - Limitation on Agency Authority of Members


