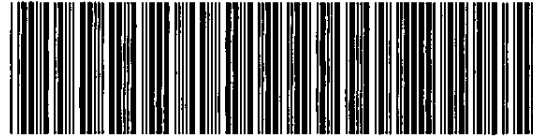



ARTICLES OF ORGANIZATION
OF

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledge, and file the following Articles of Organization.

ARTICLE I – NAME

The name of the limited liability company shall be JAMS FAMILY ENTERPRISES, LLC.

ARTICLE II – ADDRESS

ARTICLE III – DURATION

A member shall transfer his or her interest in the company as set forth in the regulations of the company, but the transferee shall have no right to participate in the management of the business and affairs of the company or become a member unless all the other members of the company other than the member proposing to dispose of his or her interest approve of the proposed transfer by unanimous written consent.

ARTICLE VIII – TERMINATION OF EXISTENCE




