ARTICLE VII- PURPOSE

The general nature of the business to be conducted by this limited liability company is to engage in any activities or business permitted under the laws of the United States of America and the State of Florida. This limited liability company may transact any lawful business allowed under the laws of the State of Florida.

ARTICLE VIII- POWERS

Unless otherwise provided in an operating agreement, this limited liability company shall have the same powers as an individual to do all things necessary to carry out its business and affairs, including, without limitation, the power to:

- (4) Purchase, receive, subscribe for, or otherwise acquire, own, hold, vote, use, sell, mortgage, lend, grant a security interest in, or otherwise dispose

of and deal in and with, shares or other interests or obligations of any other entity.

- (5) Make contracts or guarantees, or incur liabilities; borrow money; issue its notes, bonds, or other obligations, which may be convertible into or include the option to purchase other securities of the limited liability company; or make contracts of guaranty and suretyship which are necessary or convenient to the conduct, promotion, or attainment of the business of a corporation the majority of the outstanding stock which is owned, directly or indirectly, by the contracting limited liability company; a corporation which owns, directly or indirectly, a majority of outstanding membership interests of the contracting limited liable. company; or a corporation the majority of the outstanding stocker which is owned, directly or indirectly, by a corporation which owns, directly indirectly, the majority of the outstanding membership interests of the contracting limited liability company, which contracts of guarant and suretyship shall be deemed to be necessary or convenient to the conduct promotion, or attainment of the business of the contracting limited liability company; or make other contracts of guaranty and suretyship which are necessary or convenient to the conduct, promotion, or attainment of the business of the contracting limited liability company.
- (6) Lend money, invest or reinvest its funds, and receive and hold real or personal property as security for repayment.
- (7) Conduct its business, locate offices, and exercise the powers granted to it by these Articles, the operating agreement, if any, and §608.404, Florida Statutes, or any subsequent revision or re-numbering of such statute.
- (8) Select managers or managing members and appoint officers, directors, employees, and agents of the limited liability company, define their duties, fix their compensation, and lend them money and credit.
- (9) Make donations for the public welfare or for charitable, scientific, or educational purposes.
- (10) Pay pensions and establish pension plans, pension trusts, profit-sharing plans, bonus plans, option plans, and benefit or incentive plans for any or all of its current or former managers, members, officers, agents, and employees.
- (11) Be a promoter, incorporator, shareholder, partner, member, associate, or manager of any corporation, limited liability company, partnership, joint venture, trust, or other entity.

Make payments or donations or do any other act not inconsistent with the law, these Articles, or the operating agreement, if any, that furthers the business of the limited liability company.

ARTICLE IX- MANAGEMENT

Unless otherwise provided in an operating agreement, this limited liability company shall be a member-managed company.

ARTICLE X-LIMITATION OF LIABILITY

Members, managers, and managing members of this limited liability shall reflect liable, solely by reason of being a member or serving as a manager or managing member, under a judgment, decree, or order of a court, or in any other manager for debt, obligation, or liability of the limited liability company.

ARTICLE XI- OPERATING AGREEMENT
