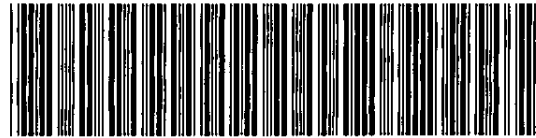

TO
AMENDED AND RESTATED
ARTICLES OF ORGANIZATION

FIRST: The name of this limited liability company is JULIA MIAMI, LLC (the "Company").

"ARTICLE I - NAME

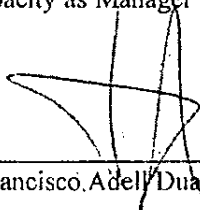
The name of the limited liability company is Miami Open City Tour, LLC (the "Company")."
