ARTICLES OF AMENDMENT TO
ARTICLES OF ORGANIZATION
OF
KPM AVENTURA, LLC
(a Florida Limited Liability Company)

FIRST: The name of the limited liability company is KPM Aventura, LLC (the "Company").

SECOND: The Articles of Organization of the Company were filed with the Secretary of State of Florida on July 26, 2012 and assigned document number L12000096896.

THIRD: The following amendments to the Articles of Organization were adopted by the Company, such amendments to be effective as of January 9, 2013:

Article 3 of the Articles of Organization of the Company is hereby amended in its entirety to read as follows:

"The sole purpose and business of the Company is to acquire and own a limited liability company interest in PMG Aventura, LLC, a Florida limited liability company, and to act with respect thereto as provided in the Amended and Restated Operating Agreement of PMG Aventura, LLC, dated as of January 10, 2013.

The Company shall not engage in any other business for so long as the Colony Indebtedness is outstanding."

Article 5 of the Articles of Organization of the Company is hereby amended in its entirety to read as follows:


