- (c) Article I of the Articles of Organization shall be deleted in its entirety and replaced by the following:

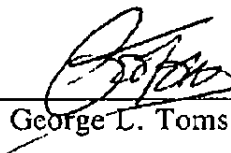
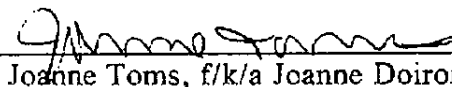
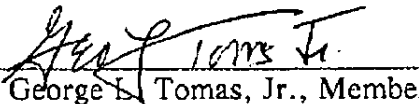
**ARTICLE I. NAME**
