**ARTICLES OF DISSOLUTION

**SECOND:** The Articles of Organization were filed on July 12, 2012 and assigned document number L12000097867.

**THIRD:** The date of the adoption of these Articles of Dissolution is 18 August 2014.

**FOURTH:** The dissolution of the Limited Liability Company was a unanimous agreement of all members. It is agreed that all debts, obligations and liabilities of the limited liability company have been paid or discharged, or that adequate provision has been made, pursuant to section 605.0709.
