- (d) Make contracts or guarantees or incur liabilities; borrow money at such rates of interest as the limited liability company may determine; issue its notes, bonds, or other obligations or secure any of its obligations by mortgage or pledge of all or an part of its property, assets, franchises or income.

- Elect or appoint managers and agents, define their duties, and fix their (g) compensation.
- Make and alter an operating agreement not inconsistent with these Articles of (h) Organization or the laws of the State of Florida.
- Make donations to the public welfare or for charitable, scientific or educational (i) purposes.
- Indemnify a Member or any other person to the same extent as a corporation may (i) indemnify any of the directors, officers, employees, or agents of the corporation against expenses actually and reasonably incurred by him or it in connection with the defense of an action, suit, or proceeding, whether civil or criminal, in which he or it is made a party.
  - Ccase its activities and surrender this Certificate of Organization. (k)
- Have and exercise all powers necessary or convenient to effect any or all of the (l) purposes for which the limited liability company is organized.
- Transact any lawful business which the Members or the managers find to be in aid (m) of governmental policy.

  - (p) Have and exercise all other powers necessary or convenient to effect its purposes.

#### ARTICLE VI <u>Registered Office and Registered Agent</u>

#### ARTICLE VIII Continuity of Business

Upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member, or upon the occurrence of any other event which terminates the continued membership of a member in the limited liability company, the business of the limited liability company shall not cease and the limited liability company shall not be dissolved unless the business of the limited liability company is terminated by the consent or agreement of the majority of the remaining Members interests. Notwithstanding the death, retirement, resignation, expulsion or bankruptcy of a Member, all contracts authorized by the limited liability company and executed by such Member in his or its representative capacity shall survive and shall inure to the benefit of the limited liability company.

## ARTICLE IX Restrictions on Membership

Contributions required of new Members shall be determined as of the time of their admission to the limited liability company. A member's interest in the limited liability company may not be sold or otherwise transferred

The operating agreement shall be repealed or altered only by the Members of the limited liability company, in the manner now or hereafter prescribed by the laws of the State of Florida.

The undersigned, being the Members of the limited liability company, hereby certifies that the foregoing constitutes the Articles of Organization of REEDY CREEK I, LLC. These Articles of Organization may be amended from time to time by the Members in the manner now or hereafter prescribed by the laws of the State of Florida.
