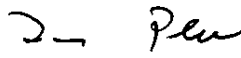

**ARTICLES OF ORGANIZATION
OF
BRING YOGA TO LIFE, LLC**

1. Name. The name of this limited liability company is BRING YOGA TO LIFE, LLC, a Florida limited liability company (the "Company").

2. Duration. The Company shall have perpetual existence commencing on the filing of the Articles of Organization with the State of Florida and continues even though a membership of a member is terminated.

3. Purpose. The company is organized for the purpose of teaching yoga and proper nutrition and eating with wellness retreats and workshops for the public and training programs and manuals for teachers and to engage in all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida.
