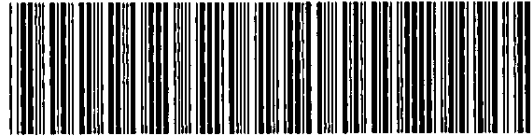

**ARTICLE I.**

Name




##### Amendment




