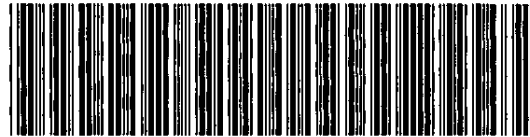



**ARTICLES OF ORGANIZATION OF**

**ARTICLE I - NAME**

**THE NAME OF THIS** Limited Liability Company shall be **BBC FAMILY, LLC,**

**ARTICLE II - ADDRESS**

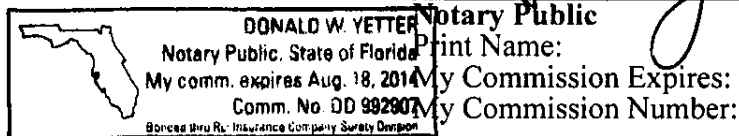
