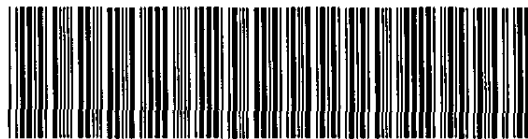

Existence and Duration of Company

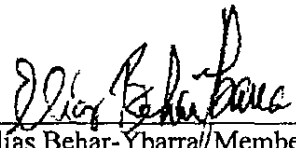
