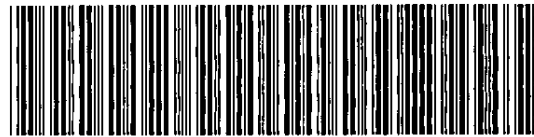

The undersigned, being the Members and Organizers of the Limited Liability Company hereby being formed under Florida Statutes, §§ 608.401 to 608.471, do hereby adopt the following articles of Organization for the Limited Liability Company:

FIRST, the name of the Limited Liability Company is:

SECOND, the latest date on which the Limited Liability Company is to dissolve is July 1, 2062.

THIRD, the Limited Liability Company is organized to engage in and do any lawful act concerning any lawful business other than banking and/or insurance, for which a limited liability company may be organized in accordance with Florida Statutes §§608.401 to 608.471, including all powers and purposes now and hereafter permitted by law to a limited liability company.




NINTH, the existing Members shall have the right to admit additional Members to the Limited Liability Company by the unanimous vote or consent of the Members.

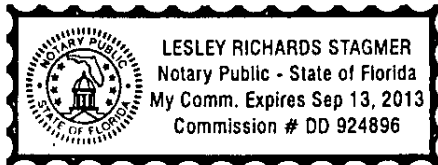


