**ARTICLE I**

**Name**

The name of the limited liability company ("Company") is VINTAGE RACING EVENTS, LLC.

**ARTICLE II**

**Address**

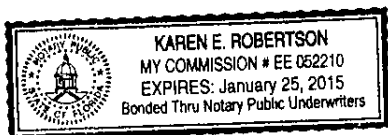


