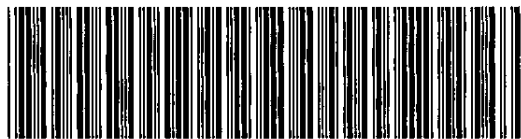

SECOND: The Articles of Organization of the Company were filed with the Florida Department of State on August 6, 2012 and assigned Document Number L12000100685.




