These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608).

**ARTICLE I - NAME**

The name of this Limited Liability Company is YEGUAS LOCAS, LLC.

**ARTICLE II - MAILING ADDRESS**

The mailing address and street address of the principal office of YEGUAS LOCAS, LLC, is 84 Country Club Road, Cocoa Beach, Florida 32931.

**ARTICLE III - DURATION**

The period of duration for YEGUAS LOCAS, LLC shall be perpetual from the date of filing these Articles with the Department of the State, except for the limitations set out in Florida Statutes Section 608.441.

**ARTICLE IV - REGISTERED AGENT & OFFICE**

The name of the initial registered agent is BARBARA SCHENCK. The street address of the initial registered agent is 84 Country Club Road, Cocoa Beach, Florida 32931.

**ARTICLE V - ADDITIONAL MEMBERS**

Additional members to the Company may be admitted, but only if all the current Members agree to the admission of the additional members and to the terms of admission.

**ARTICLE VI - TERMINATION OF MEMBERSHIP**

If a member of the Company dies, retires, resigns, is expelled, is dissolved, experiences bankruptcy, or upon the occurrence of any other event which terminates the continued membership of a Member in YEGUAS LOCAS, LLC, the remaining Members may, by unanimous agreement, continue the business of YEGUAS LOCAS, LLC.

ARTICLE VII - MANAGEMENT

YEGUAS LOCAS, LLC is to be managed by its Members and the name and address of the individuals who will serve as the Managing Members are:
