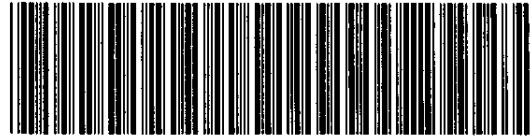

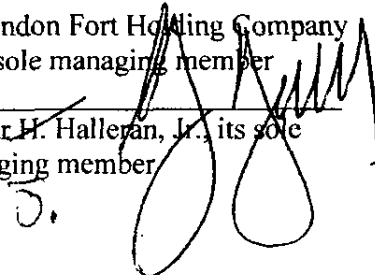
ASSIGNMENT AND ASSUMPTION AGREEMENT

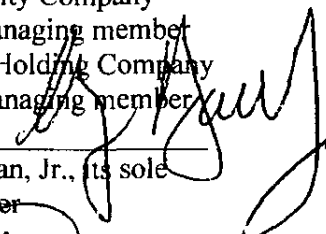

1836 hereby assumes all of the right, title and membership interest (including the rights as Managing Member) of St. Thomas in and to Reading Room.
