
#### ARTICLE VII NEW MEMBERS

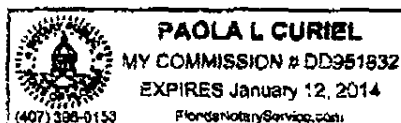
