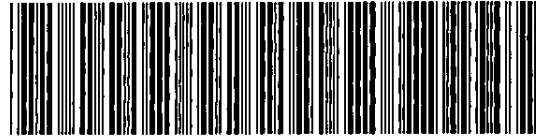

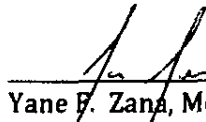
ARTICLE V - GOVERNED BY OPERATING AGREEMENT

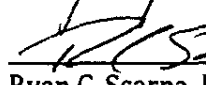
The Company shall be governed by and operated pursuant to the terms and conditions of a written Operating Agreement.
