## Articles of Organization of

a Florida Limited Liability Company

The undersigned, NELDON W. JACKSON, desires to form a limited liability company pursuant to the Florida Limited Liability Company Act. As an authorized representative of the proposed limited liability company, he does hereby make and file these Articles of Organization, and hereby declares and affirms:

#### ARTICLE I: Name

The name of the limited liability company ("Company") is RAINY DAY HONEY COMPANY, LLC, a Florida Limited Liability Company.

## ARTICLE II: Duration

The period of duration for the Company is perpetual, beginning on the date these Articles of Organization are filed by the Florida Department of State.
