**STATEMENT OF AUTHORITY FOR

**THIS STATEMENT OF AUTHORITY** is made on this 7<sup>th</sup> day of January, 2020 pursuant to §605.0302, FLORIDA STATUTES, by **BROCK LAW, L.L.C.**, a Florida limited liability company (the "Company") organized as of August 13, 2012 and Identified as Florida Document Number L12000103455, whose street address, principal place of business and mailing address is 2145 Cypress Ridge Boulevard, Suite 2020, Wesley Chapel, Florida 33544, to confirm and verify that **LEONARD H. JOHNSON**, as an **AUTHORIZED REPRESENTATIVE**, shall have the specific authority, on behalf of the Company, to:

- (a) Execute any and all document necessary to transact the business of the Company, including, but not limited to, the ability and capacity to execute, acknowledge and deliver any and all document, filing, certificate, approval, instrument, agreement, contract, conveyance, deed, mortgage, promissory note, bills of sale, affidavit, closing document, settlement statement, credit authorization, and any and all other document he may deem necessary, advisable or convenient in connection with the consummation of the Company's business, in such form and containing such terms and conditions as he/she, in his/her sole discretion, deems necessary, advisable or convenient;
- (b) Execute any instrument transferring real property or personal property held in the name of the Company; and
- (c) Enter into other transactions on behalf of, or otherwise act for or bind, the Company.

Any party in possession of this Statement of Authority shall have no duty or responsibility to further, and separately, investigate or determine the authority of **LEONARD H. JOHNSON** to act for or bind the Company, as provided herein.

This Statement of Authority may only be amended or cancelled by delivering to the Florida Department of State, Division of Corporations, a written amendment or cancellation stating:

- (a) The name of the Company as it appears on the records of the Florida Department of State, Division of Corporations;
- (b) The street and mailing addresses of the Company's principal office;
- (c) The date the statement being affected became effective; and
- (d) The contents of the amendment or a declaration that the affected statement is canceled.

This Statement of Authority shall be deemed canceled and/or restrictively amended when a certified copy of the cancellation or restrictive amendment has been recorded in the office for recording transfers of real property, or, a limitation on the grant is contained in another statement of authority that became effective after the statement containing the grant became effective and a certified copy of the later effective statement is recorded in the office for recording transfers of real property.






