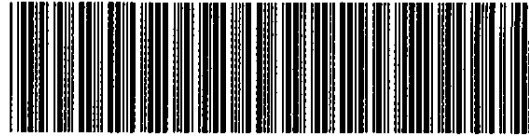

**ARTICLES OF ORGANIZATION OF  
SUNCOAST VENDING MACHINES, L.L.C.**

The undersigned, desiring to form a limited liability company under the provisions of Sections 608.401 *et seq.*, Florida Limited Liability Company Act, as amended, hereby sets forth the following:

Article I.     Name.   The name of the Limited Liability Company is SUNCOAST VENDING MACHINES, L.L.C.

Article II.     Principal Office.   The mailing address and the street address of the principal office of the Limited Liability Company is 1647 Bay Street Southeast, St. Petersburg, FL 33701.

Article III.     Registered Office and Agent.   The post office address of the initial registered office of the Limited Liability Company is located within the City of St. Petersburg at 696 First Avenue North, Suite 201, St. Petersburg, Florida 33701. The initial registered agent is G. 
