I hereby file these Articles of Correction as an authorized representative of the sole member of a limited liability company formed pursuant to the Articles of Organization and the laws of the State of Florida.

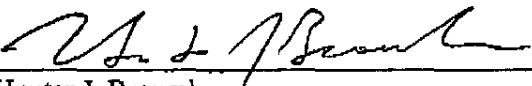
The Articles of Organization were filed with the Florida Secretary of State on August 13, 2012 and effective as of August 10, 2012. The name of the limited liability company is incorrect.
