ARTICLE IV

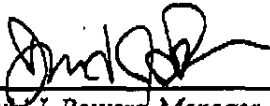
This limited liability company shall commence its existence as of the execution hereof on August 10, 2012, and shall exist perpetually thereafter unless sooner dissolved.

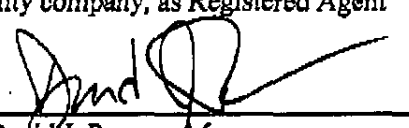
