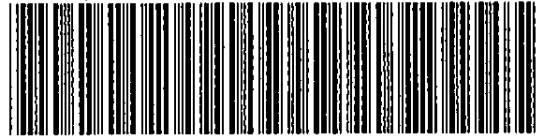

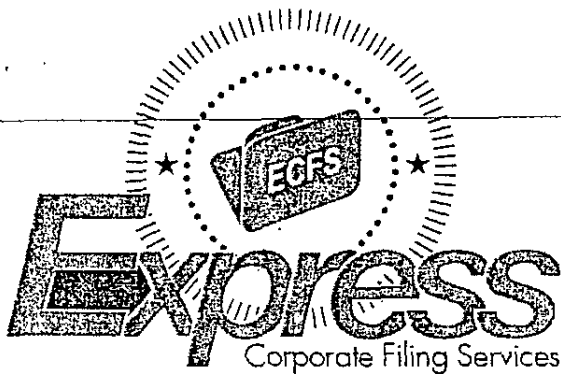



ARTICLE IV - MANAGER(S) MGR or Managing Member(s) MGRM:


