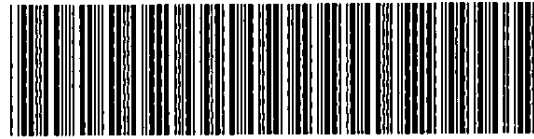

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes (the "Florida Limited Liability Company Act"), for the purpose of forming a Limited Liability Company under the laws of the State of Florida, do set forth the following:

**ARTICLE I  
NAME**

The name of the Limited Liability Company is **THE PINEAPPLE COTTAGE, LLC** (hereinafter referred to as the "Company").

**ARTICLE II  
PERIOD OF DURATION**

The period of duration of the Company shall not exceed the maximum term permitted under the Florida Limited Liability Company Act. The Company may be dissolved sooner, however, as provided in the Florida Limited Liability Company Act or the written Operating Agreement to be executed by all of the members of the Company.

**ARTICLE III  
PURPOSE**

The purpose for which the Company is organized is to engage in any and all businesses and activities permitted by the laws of the State of Florida. The Company shall have all of the powers vested in a limited liability company organized and existing by virtue of such laws. The Company shall have the power to purchase and own real and personal property, to borrow money and to mortgage and/or pledge any of its assets, including real property.

**ARTICLE VI  
REGISTERED AGENT**

INITIAL CAPITAL CONTRIBUTIONS**

ADDITIONAL CONTRIBUTIONS**

**ARTICLE IX  
CONTINUITY OF BUSINESS**

Upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member in the Company, the business of the Company shall be continued and the Company shall not be dissolved without the prior written consent of all the remaining Members of the Company.

**ARTICLE XI
