FIFTH: The Articles of Organization are hereby amended to include Article VII that shall provide as follows:

ARTICLE VII - Operating Agreement

Any Operating Agreement as defined in Section 608.402(24) of the Florida Limited Liability Company Act ("FLLCA"), relating to the Company, must be in writing and signed by all of its members.

SIXTH: The Articles of Organization are hereby amended to include Article VIII that shall provide as follows:

ARTICLE VIII - Limitation on Agency Authority of Members

Pursuant to Section 608.4235 of FLLCA, no member of the Company shall be an agent of the Company solely by virtue of being a member.

These Articles of Amendment were approved by all of the Members of the Company on September 4, 2012.
