

**ARTICLES OF ORGANIZATION  
OF  
CLIFT POOLS LLC**

These Articles of Organization are submitted for the purpose of forming a limited liability company pursuant to the Florida Limited Liability Act, Chapter 608, Florida Statutes, as the same may from time to time be amended (the "Act").

**ARTICLE I:** The name of this limited liability company ("the company") is CLIFT POOLS LLC.
