Pursuant to Sections 608.407 and 621.051 of the Florida Statutes, the undersigned hereby

ARTICLE I - NAME

The name of this professional limited liability company is JLK614, PLLC (the "Company").

ARTICLE II - ADDRESS

The Company's principal place of business shall be at 418 31st Street, West Palm Beach, Florida 33407, and such other place or places as the members from time to time may determine. The mailing address is the same as the principal place of business.

ARTICLE III - INITIAL REGISTERED AGENT


ARTICLE IV - PURPOSE

Pursuant to the authority granted under Chapter 621, Florida Statutes, the Company is formed for the purpose of providing professional legal services through attorneys at law, who may be members, officers, employees or agents, duly licensed or otherwise authorized to render such professional legal services within the State of Florida. The foregoing shall not be deemed to limit or restrict in any manner the general powers of the Company and the exercise thereof as conferred by the laws of the State of Florida upon professional limited liability companies to provide professional legal services under the provisions of Chapter 621, Florida Statutes (as it now exists or is hereinafter amended), including, without limitation, the power to invest funds of the Company in real estate, mortgages, stocks, bonds or any other type of investment, and the power to own real and personal property necessary for the rendering of its professional legal services.

ARTICLE V - RESTRICTION ON TRANSFER OF MEMBERSHIP INTERESTS

No member of the Company may sell or transfer any of its membership interest in the Company, except to another person who is then duly authorized and licensed to practice law in the State of Florida.

IN WITNESS WHEREOF, the undersigned has executed these Articles of Organization for the foregoing uses and purposes this 22 day of August 2012.


