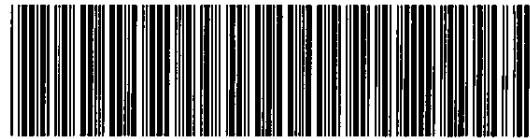

**ARTICLE I**

**Name**

The name of the Limited Liability Company is **491 UNITS MIAMI GARDENS INVESTMENT, LLC.**

**ARTICLE II**
