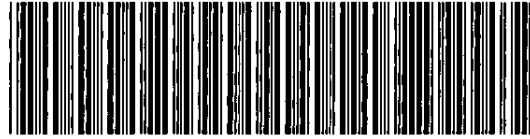

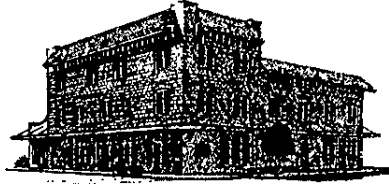

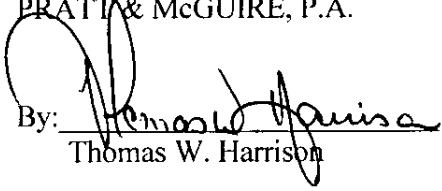

Principal Office

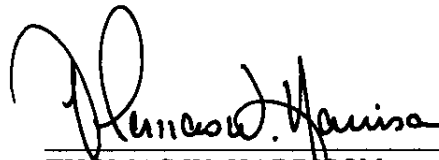

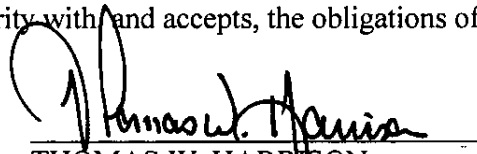
