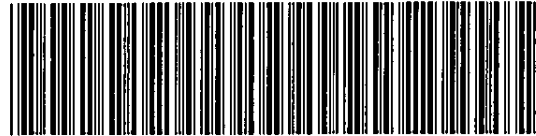

The undersigned, being authorized to execute and file these Articles of Organization, hereby certifies that:

ARTICLE I — Name:

The name of the limited liability company (hereinafter referred to as the "Company") is "G & R ENTERPRISES OF JACKSONVILLE, LLC".

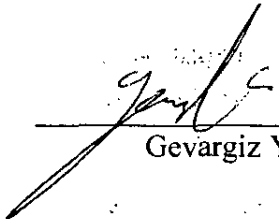

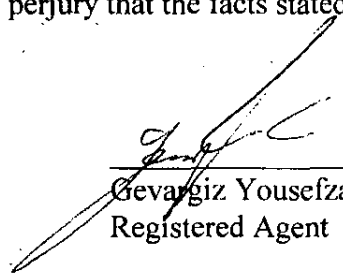
