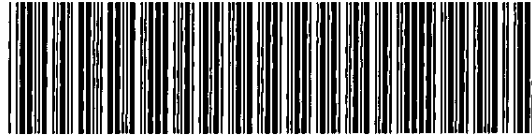

ARTICLES OF ORGANIZATION

OF

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be **KINGDOM PROPERTY MAINTENANCE LLC** ("Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 5160 Southwest 6th Street, Miami, Florida 33134 and the mailing address shall be the same.

The Company shall have all the powers granted to a limited liability company under the laws of the State of Florida.

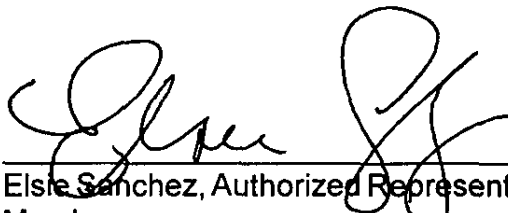

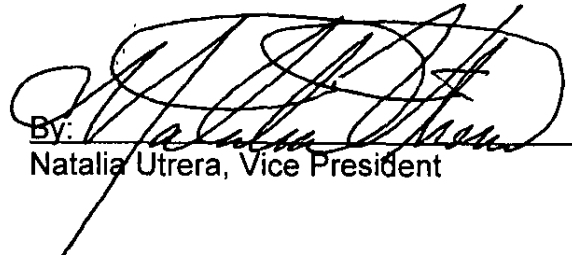
