

De-facto OFFICE SYSTEMS LLC did not work even one day. We lost money on lawers, on USCIS, on rent of the office premises as well as the car lease. That is the main reason why we decided to shut down the US branch and the company account. We had to send documents to USA, include the additional requested payment of USD 55 and then resend it to you. I was afraid that these documents would reach your office late and that is why I have paid for our company registration in 2015 in order to avoid penalties.
