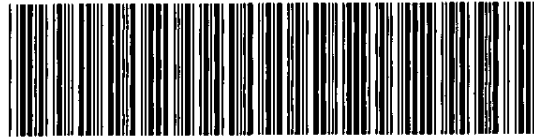

Introduction and Preliminary Statements

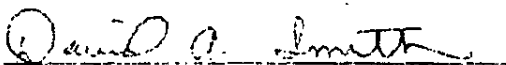
