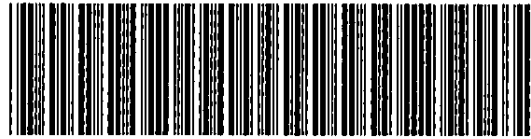

ARTICLE 1 - NAME

The name of the limited liability company shall be **APARTMENT 12 HAIR STUDIO LLC** ("Company").

ARTICLE 2 - ADDRESS

ARTICLE 3 - EFFECTIVE DATE

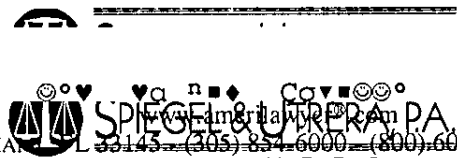
These Articles of Organization shall be effective immediately upon approval of the Secretary of State, State of Florida.




