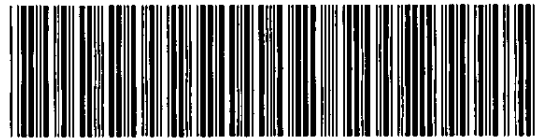

**ARTICLES OF AMENDMENT
TO
ARTICLES OF ORGANIZATION

FIRST: The Articles of Organization were filed on August 30, 2012 and assigned document number L12000111945.

SECOND: This amendment is submitted to add the following Article V:

ARTICLE V: PURPOSE.

The Company's business and purpose shall consist solely of the following:

(i) to engage solely in the ownership, operation and management of the real estate project known as Pier Park North Shopping Center, located in Panama City Beach, Florida (the "Property"), pursuant to and in accordance with these Articles of Organization and Operating Agreement for the Company (collectively, the "LLC Agreement"); and

(ii) to engage in such other lawful activities permitted to companies by the applicable laws and statutes for such entities of the State of Florida as are incidental, necessary or appropriate to the foregoing.

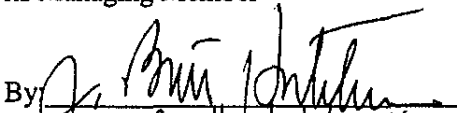
