members have decided to pursue alternative business plans.

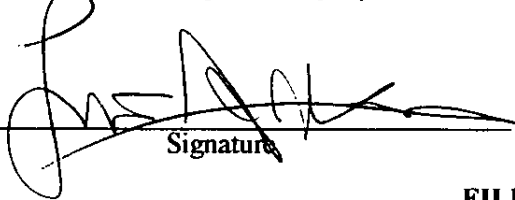
