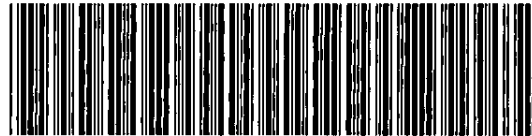

ARTICLE I - Name

The name of the limited liability company is **INVESTOR MANAGEMENT-27, LLC**

ARTICLE II - Address
