The Company's existence shall commence on filing of these Articles and it shall exist perpetually thereafter unless dissolved according to law or the Company's Operating Agreement.

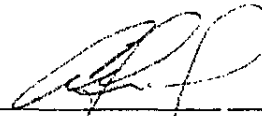

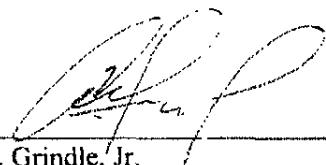
