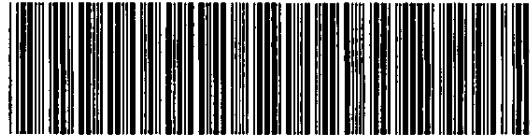

The Amendment to the Articles of Organization, pursuant to Florida Statute 608.411, is as follows:

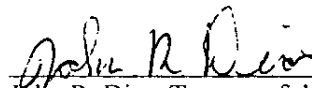

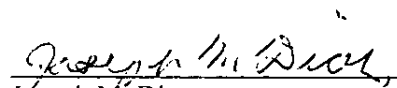

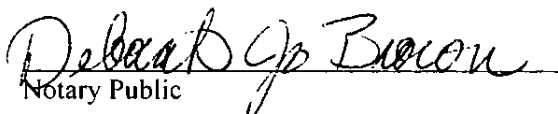
