



**ARTICLES OF ORGANIZATION
OF

1. **NAME.** The name of this limited liability company is Hidden Valley Investors, LLC (the "Company"), and it shall be formed as a limited liability company under Chapter 608 of the laws of the State of Florida.


2. **PLACE OF BUSINESS.** The mailing address and street address of the Company's principal office is 601 Bayshore Boulevard, Suite 650, Tampa, Florida 33606.


