ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION OF CHUCK'S CONCRETE PUMPING, LLC

THESE ARTICLES OF AMENDMENT TO THE ARTICLES OF ORGANIZATION OF CHUCK'S CONCRETE PUMPING, LLC, a Florida limited liability company (the "Company), are executed by the Authorized Representative of the Company for the purposes set forth herein:
