**ARTICLES OF AMENDMENT TO
THE ARTICLES OF ORGANIZATION OF
FO REALTY, LLC**

Pursuant to the provisions of Section 605.0202 of the Florida Statutes, the undersigned Florida limited liability company hereby adopts the following Articles of Amendment to its Articles of Organization:

ARTICLE I - NAME; DATE OF FILING

The name of the limited liability company is FO REALTY, LLC (hereinafter referred to as the "Company"). The date of filing of the Company's Articles of Organization was September 6, 2012, and the Company was assigned document number L12000114482.

ARTICLE III - ADOPTION AND TEXT OF AMENDMENT

All of the Members of the Company unanimously approved a resolution amending Article V of the Articles of Organization by written consent in accordance with the provisions of Section 608.4231(8) of the Florida Statutes. Article V


