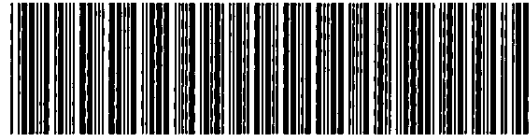

The name of the limited liability company shall be **FIVE STAR FAMILY GROWERS-FARM OFFICE, LLC** ("Company").




