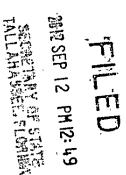

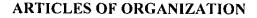

ARTICLE I - NAM E

The name of the limited liability company shall be GARFAM ENTERPRISES, LLC.

ARTICLE II - PRINCIPAL PLACE OF BUSINESS AND ADDRESS

The principal place of business and the address of the Company in Florida shall be 6805 Forestwood Drive West, Lakeland, Florida 33811, and its mailing address is the same.
