## **ARTICLES OF ORGANIZATION OF SAMDOGS, LLC**

The undersigned certify that we have associated ourselves together for the purpose of becoming a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of limited liability companies for profit. We further declare that the following Articles shall serve as the Charter and authority for the conduct of business of the limited liability company

### **ARTICLE I NAME AND MAILING ADDRESS & STREET ADDRESS OF PRINCIPAL OFFICE**

The name of the limited liability company shall be SAMDOGS, LLC, [hereinafter the "Company"] and its principal office's street address shall be 1732 Hickory Gate Drive S, Dunedin, FL 34698 and its mailing address shall be 1732 Hickory Gate Drive S, Dunedin, FL 3468, but it shall have the power and authority to establish branch offices at any other place or places as the members may designate.

### **ARTICLE II PURPOSES AND POWERS**

The Company is established and authorized to engage in any lawful activity and business. In addition to the powers authorized by the laws of the State of Florida for limited liability companies, the general nature of the business or businesses to be transacted, and which the limited liability company is authorized to transact, the Company shall possess all the powers which an individual possesses to carry out its affairs and businesses.

### **ARTICLE III EXERCISE OF POWERS & MANAGEMENT**

All limited liability company powers shall be exercised by, and the business and affairs of the Company shall be managed under the direction of, the members of this limited liability company.

### **ARTICLE IV MEMBERSHIP RESTRICTIONS**

Members shall have the right to admit new members as provided in the Company's Operating Agreement as amended from time to time. A member's interest in the Company may not be sold, assigned or otherwise transferred except as provided in the Company's Operating Agreement, as amended from time to time. On the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member, or the occurrence of any other event that terminates the continued membership of a member in the Company, the remaining members shall have the right to continue the business on the unanimous consent of the remaining members.

**ARTICLE V  
DURATION**

This Company shall exist perpetually, or until dissolved in a manner provided by law, or as provided in the Operating Agreement adopted by the members.
